The work is generally described as follows:

The Town Hall Renovation located at 325 W. White Mountain Boulevard, Lakeside, AZ 85929 consists of approximately 9,457 square feet of area. The project will consist of the following:

1. Council Chambers construction
2. Bathroom construction
3. Conform new construction to material and style of existing

All construction debris must be disposed of and the facility left in pristine condition. The work includes all required labor, material, transportation and services for the project to complete a usable and operable facility in accordance with all pertinent codes and regulations as necessary to complete the job in a workmanlike manner as shown on the Construction and Bid Documents. The Contractor shall furnish all labor, equipment, materials and incidentals as may be required to accomplish the project(s) outlined in the Bid Form.
