**RESOLUTION NO. 19-1508**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE AUTHORIZING ENTERING INTO AN INTERGOVERNMENTAL AGREEMENT ADOT NO. IGA 18-007225-I BETWEEN THE STATE OF ARIZONA AND THE TOWN OF PINETOP-LAKESIDE.**

**WHEREAS**, the Town of Pinetop-Lakeside (“Town”) is in agreement with the terms and conditions of the Intergovernmental Agreement between the Town and the State of Arizona (“State”) , ADOT No. IGA 18-0007225-I, regarding the construction of Billy Creek Pedestrian Bridge and pedestrian amenities on the section of Porter Mountain Road from SR260 – Peterson Lane; and

**WHEREAS**, the State is empowered by ARS § 28-334 and § 28-401 to enter into this Agreement and has delegated authority to execute this Agreement on behalf of the State; and

**WHEREAS**, the Town is empowered by ARS § 9-240 to enter into this Agreement and is delegating authority to execute this Agreement on behalf of the Town; and

**WHEREAS**, the Town desires to utilize Highway User Revenue Funds (“HURF”) Exchange funding for construction of a multi-use bridge over Billy Creek, hereinafter referred to as the “Project;” and

**WHEREAS**, the primary purpose of this Project is the improvement of the efficiency, reliability and safety of the traveling public; and

**WHEREAS**, the Town is representing to the State that it will be able to, and will, meet schedule requirements and requirements cited within the Agreement.


**BE IT RESOLVED** by the Town of Pinetop-Lakeside, Arizona, as follows:


