
SUMMARY/STAFF RECOMMENDATION:

Staff recommends the appointment of Jill Akins as Town Clerk for the Town of Pinetop-Lakeside. Ms. Akins began working for the Town of Pinetop-Lakeside in July 2013 in the Clerks Office as an Administrative Secretary. She became the Assistant to the Town Clerk in January of 2014 and the Deputy Clerk in October of 2016.

It is staff's recommendation that Jill Akins be appointed as Town Clerk, at a salary of \$50,336, as she is well qualified to fill the position.
