

TOWN OF PINETOP-LAKESIDE

RESOLUTION NO. 19-1523

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ACCEPTING THE PRIMARY BID IN THE AMOUNT OF \$1,266,485.10 AND ENTERING INTO A CONSTRUCTION CONTRACT WITH RAWLINGS SPECIALTY CONTRACTING, LLC. TO COMPLETE THE PINETOP-LAKESIDE BILLY CREEK PEDESTRIAN BRIDGE AND PATHWAY PROJECT NO. PW 19-005; AND AUTHORIZE THE TOWN MANAGER TO EXECUTE ANY AND ALL DOCUMENTS IN CONNECTION WITH THE PROJECT.

WHEREAS, the Project is funded by HURF and HURF exchange funds from the 2019-2020 Fiscal Budget; and

WHEREAS, the Town of Pinetop-Lakeside conducted a bid opening on September 11, 2019 for the Pinetop-Lakeside Billy Creek Pedestrian Bridge and Pathway Project No. PW 19-005 (“Project”); and

WHEREAS, the Town of Pinetop-Lakeside received one (1) sealed bid, with Rawlings Specialty Contracting, LLC. submitting the lowest, responsive, responsible primary bid in the amount of \$1,266,485.10; and

WHEREAS, Town Staff after reviewing the bid packet, and the qualifications of Rawlings Specialty Contracting, LLC., recommends entering into to a Construction Contract with the lowest responsive, responsible bidder, Rawlings Specialty Contracting, LLC. for this Project; and


WHEREAS, the Town of Pinetop-Lakeside is in agreement with the terms and conditions set forth in the Contract Documents between Rawlings Specialty Contracting and the Town;

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona approve Resolution No. 19-1523:

1. Accepting the primary bid in the amount of \$1,266,485.10 and entering into a Construction Contract with Rawlings Specialty Contracting, LLC. to complete the Pinetop-Lakeside Billy Creek Pedestrian Bridge and Pathway Project No. PW 19-005; and
2. Authorizing the Town Manager to execute any and all documents necessary to complete this project.
