RESOLUTION NO. 14-1311

A RESOLUTION BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, SUPPORTING THE JOINT SUBMISSION OF A PROGRAM APPLICATION TO THE DOLLAR GENERAL LITERACY FOUNDATION BY THE FRIENDS OF PINETOP-LAKESIDE LIBRARY, INC. AND PINETOP-LAKESIDE PUBLIC LIBRARY TO ADVANCE LITERACY PROGRAMS.

WHEREAS, the Pinetop-Lakeside Public Library's (Library) mission is to provide access to information, materials, and services for community residents of all ages; and

WHEREAS, the mission of the Friends of the Pinetop-Lakeside Library, Inc. (Friends) a 501 c (3) nonprofit organization, formed to organize, establish, and is dedicated to maintain an association of persons interested in books and libraries; and

WHEREAS, the Town of Pinetop-Lakeside is supportive of the Friends and the organization's mission; and

WHEREAS, the Library and the Friends will submit a joint application to the Dollar General Literacy Foundation that will further the advancement of youth literacy programs within our community and region; and

WHEREAS, the Dollar General Literacy Foundation application and proposal will apply to the Library's Game on! Program; and

WHEREAS, the Library and Town personnel will develop and submit the application to the Dollar General Literacy Foundation for consideration not to exceed \$4,000; and

WHEREAS, the Town of Pinetop-Lakeside will assign personnel for all aspects of program management to fulfill program and reporting requirements; and

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Town of Pinetop-Lakeside authorize and support the joint application to be made to the Dollar General Literacy Foundation by the Friends of the Pinetop-Lakeside Library, Inc. and Pinetop-Lakeside Public Library to advance literacy programs, and authorize the Mayor to sign the application and contract(s) or grant document(s) required for receipt and use of these funds:

AND, authorize the Mayor to take all actions necessary to implement and complete the activities submitted in the said application; and

THAT, the Town of Pinetop-Lakeside will comply with all Dollar General Literacy Foundation Program guidelines, requirements and applicable certifications contained in the application.
