

TOWN OF PINETOP-LAKESIDE

RESOLUTION NO. 16-1378

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA PERTAINING TO THE COMMERCIAL LEASE FOR RIM COMMUNICATIONS TOWER SITE ON PORTER MOUNTAIN AND MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF SHOW LOW AND THE TOWN OF PINETOP-LAKESIDE FOR SHARED SPACE AT THE LEASE SITE.

WHEREAS, the Town of Pinetop-Lakeside, through the Pinetop-Lakeside Police Department, wishes to enter into agreement with Rim Communications, LLC, to lease space from Rim Communications on their Porter Mountain site. This request is necessary to complete the next phase of the Police Department Public Safety Radio Project; the term of the lease would be for two years, at a monthly rate of \$150.00.

WHEREAS, the Town of Pinetop-Lakeside, through the Pinetop-Lakeside Police Department, seeks approval to enter into agreement with the City of Show Low in a Memorandum of Understanding for a term of two years, whereby the City of Show Low agrees to pay a fair proportional cost of 50 percent of the Town's monthly rental fee which is currently \$150.00 for shared space at the tower site.


WHEREAS, the Town of Pinetop-Lakeside, through the Pinetop-Lakeside Police Department, is in agreement with the terms and conditions of the Contract Agreement between Rim Communications and the City of Show Low.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Town of Pinetop-Lakeside, Arizona as follows:

1. THAT approval of the agreement with Rim Communications, LLC, to lease space from Rim Communications on their Porter Mountain site for the term of two years at a monthly rate of \$150.00.
2. THAT approval to enter into agreement with the City of Show Low in a Memorandum of Understanding for a term of two years, whereby the City of Show Low agrees to pay a fair proportional cost of 50 percent of the Town's monthly rental fee which is currently \$150.00 for shared space at the tower site.


