**RESOLUTION NO. 16-1383**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, AUTHORIZING THE TOWN OF PINETOP-LAKESIDE POLICE DEPARTMENT TO PURCHASE A DUI ALCOHOL ENFORCEMENT MARKED POLICE PACKAGE TRUCK AT A PURCHASE PRICE NOT TO EXCEED \$47,000.00 UTILIZING GOVERNOR'S OFFICE OF HIGHWAY SAFETY (GOHS) FUNDS.**

**WHEREAS**, the Pinetop-Lakeside Police Department has relied upon the Governor's Office of Highway Safety funds to support participation in DUI TASK Force enforcement program; and

**WHEREAS**, the Pinetop-Lakeside Police Department continues to work cooperatively with regional partners in the White Mountain DUI Task Force as a means to address the current DUI issues; and

**WHEREAS**, with funding assistance from GOHS (since 2004), Pinetop-Lakeside Police Department has led the way in forming the White Mountain DUI Task Force to address DUI issues and local DUI arrests have continued to decline; and

**WHEREAS**, during peak seasons, holiday and special events the Town of Pinetop-Lakeside Police Department experiences a spike in DUI offenses and arrests due to the increased visitors; and

**WHEREAS**, GOHS grant funds will purchase a fully Marked DUI Alcohol Enforcement Police Package Truck to support and enhance DUI Alcohol Enforcement efforts throughout the Town of Pinetop-Lakeside.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona, hereby authorizes the purchase of a fully Marked DUI Alcohol Enforcement Police Package Truck to support and enhance DUI Alcohol Enforcement throughout the Town of Pinetop-Lakeside at a purchase price not to exceed \$47,000.00 utilizing Governor's Office of Highway Safety funds, and authorize the Mayor to execute any and all documents.
