RESOLUTION NO. 15-1328**

**A RESOLUTION BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, TO SUBMIT AN APPLICATION TO THE AMERICAN LIBRARY ASSOCIATION PUBLIC PROGRAMS OFFICE FOR THE FY 2015 STORYCORPS PROGRAM TRAINING AND EQUIPMENT RESOURCES, AND LEVERAGE FUNDS.**

**WHEREAS**, the Pinetop-Lakeside Public Library's (Library) mission is to provide access to information, materials, and services for community residents of all ages; and

**WHEREAS**, the Library is seeking assistance to enhance the Library's programs and collections; and

**WHEREAS**, the StoryCorps @ Your Library Program is sponsored by the American Library Association Public Programs Office the support from the Institute of Museum and Library Services (IMLS); and

**WHEREAS**, StoryCorps @ Your Library Program interview methods and resources are used to create a local audio collection that libraries will use to produce high-quality library programming that will expand influence and engagement in the communities; and

**WHEREAS**, the StoryCorps @ Your Library Program equips libraries with equipment, training, promotional materials and other resources to assist with the development of community documentation projects; and

**WHEREAS**, the selected libraries will receive the materials at no cost or match requirements, grant recipients will responsible for recorded interviews; and

**WHEREAS**, the Pinetop-Lakeside Public Library staff will facilitate the project management required to receive training and programs; and

**WHEREAS**, the Town of Pinetop-Lakeside will leverage a monetary match not to exceed \$1,500 for library staff program mileage reimbursement.


