**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ADOPTING A FEE SCHEDULE FOR TOWN CEMETERY.**

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Town Council of the Town of Pinetop-Lakeside hereby adopt the Town Cemetery Fees as follows:

**DESCRIPTION OF SERVICES**

RESERVATION PRICES (Recording fees included when paid in full):

Resident of Pinetop Lakeside – Single Plot	\$750.00
Resident of Pinetop Lakeside-Companion Plot	\$900.00
Navajo County Residents – Single Plot	\$1000.00
Out of Navajo County Resident – Single Plot	\$3000.00
Infant/Half Grave	\$500.00

\*A resident of Pinetop-Lakeside or a person owning property in Pinetop-Lakeside can purchase a burial plot at the Pinetop-Lakeside resident rate. Former residents of Pinetop-Lakeside with relatives buried within the cemetery may purchase burial plots or burial spaces at the Navajo County resident rate.



INTERMENT DELAYS


A fee equal to one and one half (1 ½) times the current man-hour rate shall be charged for burial services that are delayed or begin later than the time scheduled.

PASSED AND ADOPTED at a regular meeting of the Town Council of the Town of Pinetop-Lakeside, Arizona on April 21, 2016.


