The Council may direct staff to study the matter and reschedule for further consideration at a later date. Items on the agenda will not be heard or discussed in Call to the Public. Individuals are limited to three (3) minutes. *Tony Alba offered comments.*

There will be no separate discussion of these items unless a Member of Town Council requests that an item or items be removed for discussion.
