RESOLUTION NO. 19-1498

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, AUTHORIZING THE CITY OF BUCKEYE'S JOB ORDER CONTRACT (JOC) STREET MAINTENANCE NO. 2014-006 WITH SUNLAND ASPHALT & CONSTRUCTION, INC. TO COMPLETE PAVEMENT PRESERVATION PROJECT PW 19-001.

WHEREAS, the Town of Pinetop-Lakeside ("Town") Public Works Department has completed the Town's 2019 Pavement Preservation Schedule to complete Pavement Preservation Project PW 19-001; and

WHEREAS, the Town of Pinetop-Lakeside has requested and received permission to utilize the City of Buckeye's Job Order Contract which meets State of Arizona Procurement Code A.R.S. § 41-2632 allowing the Town to use, and participate in a Job Order Contract; and

WHEREAS, the City of Buckeye's Job Order Contract No. 2014-006 with Sunland Asphalt & Construction, Inc. is applicable to complete the Town's Pavement Preservation Project PW 19-001; and

WHEREAS, the Town's Pavement Preservation Project PW 19-001 scope of work will complete Full Depth Reclamation and Overlay application on Juniper Lane within the Town; and

WHEREAS, Sunland Asphalt & Construction ("Contractor") is a licensed and bonded contractor is familiar and worked on pavement preservation project(s) for, and around the Town of Pinetop-Lakeside; and

WHEREAS, the Contractor's Bid Response Quote to the Town is \$222,478.01 under the terms and conditions of Buckeye's Job Order Contract No. 2014-006 is deemed fair and equitable to current and past projects associated with, or around the Town of Pinetop-Lakeside and attached as Exhibit "A;" and

WHEREAS, the City of Buckeye's Job Order Contract No. 14-006 packet is attached as Exhibit "B.1 – B-4."

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona, hereby adopting Resolution No. 19-1498, utilizing the City of Buckeye's Job Order Contract No. 2014-006 with Sunland Asphalt & Construction, Inc. to:

- 1) Complete the Street Maintenance Project PW 19-001;
- 2) Authorize the Town Manager to execute all documents necessary to execute this with the Street Maintenance Project PW 19-001.


