**RESOLUTION NO. 21-1570**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ACCEPTING THE EMERGENCY PROCUREMENT CONTRACT WITH CANYON CREEK LOGGING, INC., TO COMPLETE THE WOODLAND LAKE PARK BARK BEETLE TREATMENT (WESTERN BARK BEETLE INITIATIVE GRANT) PROJECT NO. PR 20-011; AND AUTHORIZE THE TOWN MANAGER TO EXECUTE ANY AND ALL DOCUMENTS IN CONNECTION WITH THE PROJECT.**

**WHEREAS**, the Project is funded jointly by Arizona Department of Forest and Fire Management's Western Bark Beetle Initiative Grant Program (WBBI) and Town of Pinetop-Lakeside funds from the 2020-2021 Fiscal Budget; and

**WHEREAS**, the Town of Pinetop-Lakeside solicited quotes for the Woodland Lake Park Bark Beetle Treatment Project No. PR 20-011 ("Project"); and

**WHEREAS**, the Town of Pinetop-Lakeside received one (1) response with Canyon Creek Logging, Inc. submitting the only, responsive, responsible quote in the amount of \$81,000.00; and

**WHEREAS**, Town Staff, after reviewing the quote and the qualifications of Canyon Creek Logging, Inc., recommends entering into a Contract with the only respondent, Canyon Creek Logging, Inc. for this Project; and

**WHEREAS**, the Town of Pinetop-Lakeside is in agreement with the terms and conditions set forth in the Contract Documents between Canyon Creek Logging, Inc. and the Town;

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona approve Resolution No. 21-1570:

1. Accepting the bid amount of \$81,000.00 and entering into a Contract with Canyon Creek Logging, Inc. to complete the Woodland Lake Park Bark Beetle Treatment Project No. PR 20-011; and
2. Authorizing the Town Manager to execute any and all documents necessary to complete this project.
