RESOLUTION NO. 21-1585

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, APPROVING A MEMORANDUM OF UNDERSTANDING FOR THE NORTHEASTERN ARIZONA 9-1-1 USERS ASSOCIATION (NAUA), BETWEEN NAVAJO COUNTY AND APACHE COUNTY SHERIFF'S OFFICE, SHOW LOW POLICE DEPARTMENT, PINETOP-LAKESIDE POLICE DEPARTMENT, SNOWFLAKE-TAYOR POLICE DEPARTMENT AND WHITE MOUNTAIN APACHE TRIBAL POLICE DEPARTMENT, FOR 9-1-1 BILL PAYMENT PROCEDURE.

RECITALS:

WHEREAS, the Town Council is authorized and empowered to enter into this Agreement pursuant to A.R.S. § 11-952; and

WHEREAS, The Navajo County Sheriff's Office, NAUA System Administrator, has been designated to perform 9-1-1 System communication/telephone bill payment administrative functions for local NAUA subscribers. The System Administrator also serves as the ADOA-GFR Arizona 9-1-1 Grant award administrator; and

WHEREAS, the Pinetop-Lakeside Police Department desires to partner with subscriber agencies to provide documentation to the NAUA System Administrator, as requested, which may be necessary in connection with the ADOA-GFR Arizona 9-1-1 Grant Award. Also, share GIS data that supports Next-Gen Core Services such as Site Structure Address Points/SSAP, Road Centerlines, PSAP Boundaries, ESN, ESB Boundaries, and Parcel to Navajo County GIS Department to maintain their data supply chain for the state geospatial initiatives.


ENACTMENTS:

- Section 2. That the Chief of Police, is appointed agent for the Town of Pinetop-Lakeside, to conduct all negotiations, execute and submit all documents and any other necessary or desirable instruments in connection with the Memorandum of Understanding.


