

TOWN OF PINETOP-LAKESIDE

ORDINANCE 22-446

AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ADOPTING THE TOWN CODE AMENDMENTS TO Title 10 VEHICLES AND TRAFFIC.

WHEREAS, the Town Council of the Town of Pinetop-Lakeside believes that amending the Town Code Title 10 VEHICLES AND TRAFFIC is in the best interest of the citizens of the Town.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, NAVAJO COUNTY, ARIZONA, as follows:

Section 1. **Adoption.** Title 10 Chapter 10.02 GENERAL PARKING REGULATIONS is hereby amended and adopted and made a part of that certain document known as the "Pinetop-Lakeside Town Code." Three (3) copies of Title 10 Chapter 10.02 GENERAL PARKING REGULATIONS are on file with the Town Clerk of the Town of Pinetop-Lakeside, Arizona, which document was made a Public Record by Resolution No. 22-1608 of the Town of Pinetop-Lakeside, Arizona; and hereby referred to, adopted, and made a part hereof as if fully set forth in this Ordinance.

Section 2. **Penalty Provision.** The following penalty provision that is set forth in Chapter 10.02 General Parking Regulations is included in this Ordinance 22-446 as required by A.R.S. §9-803.

10.02.050 Violation-Penalty

Civil Traffic Violations: Any Violation of or failure or refusal to do or perform any act required by Title 10 shall constitute a civil traffic violation. Civil traffic violations are subject to the provisions of A.R.S. Title 28 any amendments thereto, and rules of procedure of civil traffic offences.

Any person found guilty of violating any provision of this chapter shall be subject to a civil sanction which shall not exceed sixty dollars (\$60.00).

Civil sanctions, if any, shall be levied in addition to any towing costs which result from the towing of a vehicle pursuant to this chapter.

Section 3. **Effective Date.** This Ordinance is to be effective when publication and posting pursuant to A.R.S. § 9-812 is accomplished.

Section 4. **Severability.** All ordinances, or parts of ordinances, adopted by the Town of Pinetop-Lakeside in conflict with the provisions of this ordinance or any part of the Town Code adopted herein by reference, are hereby repealed, effective as of the day this ordinance is effective.

PASSED AND ADOPTED by the Mayor and Town Council in an open meeting by the Town Council, Town of Pinetop-Lakeside, Arizona, this 17th day of February 2022, to be effective upon the expiration of a thirty (30) day period following adoption and publication pursuant to A.R.S. § 9-812 is complete.
