RESOLUTION NO. 22-1611

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, NAVAJO COUNTY, ARIZONA, DECLARING AS PUBLIC RECORD A CERTAIN DOCUMENT FILED WITH THE TOWN CLERK AND ENTITLED “TOWN CODE AMENDMENTS TO TITLE 16 SUBDIVISIONS AND TITLE 12 STREETS, SIDEWALKS, AND PUBLIC PLACES.”

WHEREAS, that certain document entitled “**Town Code Amendments to Title 16 Subdivisions and Title 12 Streets, Sidewalks, and Public Places,**” attached hereto as Exhibit A, three (3) copies of which shall be filed in the Office of the Town Clerk pursuant to this Resolution, shall remain on file with the Town Clerk; and

WHEREAS, A.R.S. § 9-802 permits the enactment and publication by reference of a code or public record, including statute, rule or regulation of the municipality, in the interest of economy; and

WHEREAS, the document entitled “**Town Code Amendments to Title 16 Subdivisions and Title 12 Streets, Sidewalks, and Public Places,**” is a lengthy ordinance to be adopted by Ordinance No. 22-447 , and which would qualify for enactment by reference.

NOW, THEREFORE, BE IT RESOLVED, the Mayor and Town Council of the Town of Pinetop-Lakeside hereby declare that the documents entitled “**Title 16 Subdivisions**” and “**Title 12 Streets, Sidewalks, and Public Places,**” are hereby declared a Public Record for the purpose of adoption by reference pursuant to Ordinance No. 22-447 , and order that three (3) copies of the document entitled “**Town Code Amendments to Title 16 Subdivisions and Title 12 Streets, Sidewalks, and Public Places,**” be permanently filed in the Office of the Town Clerk and available for public inspection.
