RESOLUTION NO. 18-1451

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE NAVAJO COUNTY SHERIFF'S OFFICE AND THE CITIES OF WINSLOW AND SHOW LOW, TOWNS OF SNOWFLAKE-TAYOR AND PINETOP-LAKESIDE, REGARDING BYRNE GRANT FUNDING FOR FISCAL YEAR 2017-2018.

RECITALS:

WHEREAS, the Navajo County Sheriff's Office and the above named municipalities are members of the Navajo County Major Crimes Apprehension Team (MCAT), a multi-agency, multi-jurisdictional task force that is dedicated to the investigation of the sale of illegal drugs within Navajo County; and

WHEREAS, the Navajo County Sheriff's Office is the grant manager for the Arizona Criminal Justice Commission Drug, Gang and Violent Crime Control Grant Agreement (hereafter, "Byrne Grant"); and

WHEREAS, the County has received Byrne Grant Funding that it desires to share with the above-named municipalities on a "pass-through basis," pursuant to the terms and conditions of the grant, and

WHEREAS, the Town of Pinetop-Lakeside desires to receive the aforementioned Byrne Grant funding in order to enable their participation with the MCAT team and are willing to comply with all terms and conditions of the grant, and

WHEREAS, the Town of Pinetop-Lakeside and above listed organizations are authorized by Arizona Revised Statutes Section 11-952 to enter into this Intergovernmental Agreement.


ENACTMENTS:
