

**TOWN OF PINETOP-LAKESIDE**

**RESOLUTION NO. 22-1616**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ACCEPTING THE BID IN THE AMOUNT OF \$70,500.00 AND ENTERING INTO A LANDSCAPE MAINTENANCE CONTRACT WITH IN BLOOM NURSERY – IT’S MAGIC LANDSCAPE & DESIGN; AND AUTHORIZE THE TOWN MANAGER TO EXECUTE ANY AND ALL DOCUMENTS IN CONNECTION WITH THE CONTRACT.**

**WHEREAS**, the Town of Pinetop-Lakeside (“Town”) maintains landscape within our incorporated boundaries in numerous locations, including the two major parks Woodland Lake Park and Mountain Meadow Recreation Complex; and

**WHEREAS**, the Town has added additional Facilities and the Parks Division has expanded its duties with additional park areas and facilities; and

**WHEREAS**, Town staff has reviewed past practices of 1) hiring temporary seasonal help to assist the Parks crews with landscape maintenance; 2) providing the requisite supervision at each location, and is recommending a different approach; and

**WHEREAS**, Town staff conducted a mandatory pre-bid meeting May 3, 2022, and a bid opening on May 18, 2022, for landscape maintenance services; and

**WHEREAS**, the Town of Pinetop-Lakeside received one (1) sealed bid, with In Bloom Nursery – It’s Magic Landscape & Design submitting a responsive bid in the amount of \$70,500.00; and

**WHEREAS**, Town Staff reviewed the bid packet, and qualifications of Contractor, and recommends entering into a Contract with In Bloom Nursery – It’s Magic Landscape and Design; and

**WHEREAS**, the Town of Pinetop-Lakeside is in agreement with the terms and conditions set forth in the Contract Documents between In Bloom Nursery – It’s Magic Landscape and Design and the Town.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona approve Resolution No. 22-1616.


