

**TOWN OF PINETOP-LAKESIDE**

**RESOLUTION NO. 18-1444**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ACCEPTING THE PRIMARY BID IN THE AMOUNT OF \$130,672.45 AND ENTERING INTO A CONSTRUCTION CONTRACT WITH AMERICAN PAVEMENT PRESERVATION, LLC TO COMPLETE THE PINETOP-LAKESIDE SLURRY SEAL PROJECT NO. PW 18-001; AND AUTHORIZE THE TOWN MANAGER TO EXECUTE ANY AND ALL DOCUMENTS IN CONNECTION WITH THE PROJECT.**

**WHEREAS**, the Project is funded by street funds from the 2018 Fiscal Budget; and

**WHEREAS**, the Town of Pinetop-Lakeside conducted a bid opening on February 20, 2018 for the Pinetop-Lakeside Slurry Seal Project No. PW 18-001 (“Project”); and

**WHEREAS**, the Town of Pinetop-Lakeside received three (3) sealed bids, with American Pavement Preservation, LLC submitting the lowest, responsive, responsible primary bid in the amount of \$130,672.45; and

**WHEREAS**, Town Staff after reviewing all bid packets, and the qualifications of American Pavement Preservation, LLC, recommends entering into a Construction Contract with the lowest, responsive, responsible bidder, American Pavement Preservation, LLC for this Project; and


**WHEREAS**, the Town of Pinetop-Lakeside is in agreement with the terms and conditions set forth in the Contract Documents between American Pavement Preservation, LLC and the Town.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona approve Resolution No. 18-1444:


