RESOLUTION NO. 22-1642

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, AUTHORIZING THE PURCHASE OF TRANSPORTABLE BLEACHERS FOR MOUNTAIN MEADOW RECREATION COMPLEX SOCCER/MULTI-PURPOSE FIELDS THROUGH OMNIA PARTNERS CONTRACT #R201101 TO BSN SPORTS, LLC, IN AN AMOUNT NOT TO EXCEED \$58,716.28; AND AUTHORIZE THE TOWN MANAGER TO EXECUTE ALL DOCUMENTS NECESSARY TO COMPLETE THIS TRANSACTION.

WHEREAS, the Town of Pinetop-Lakeside (Town) Town Council approved the FY 2022/23 budget, and the Town's Capital Improvement Plan (CIP) cited in Public Works Parks Capital Improvements; and

WHEREAS, Town staff has received a quote for purchase of Transportable Bleachers (Exhibit A) utilizing an OMNIA ® Partners Contract #R201101 (Exhibit B), and has determined it is in the best interest of the Town to utilize this contract to purchase bleachers,

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona approve the purchase of transportable bleachers utilizing Omnia Partners Contract #R201101 from BSN Sports, LLC, in an amount not to exceed \$58,716.28 and authorize the Town Manager to execute all documents necessary to complete this transaction.
