**RESOLUTION NO. 22-1643**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, AUTHORIZING THE PURCHASE OF CONCRETE PICNIC TABLES FOR TOWN PARKS FROM THE PETERSEN MANUFACTURING COMPANY, INC., IN AN AMOUNT NOT TO EXCEED \$49,996.00; AND AUTHORIZE THE TOWN MANAGER TO EXECUTE ALL DOCUMENTS NECESSARY TO COMPLETE THIS TRANSACTION.**

**WHEREAS**, the Town of Pinetop-Lakeside (Town) Town Council approved the FY 2022/23 budget, and the Town’s Capital Improvement Plan (CIP) cited in Public Works Parks Capital Improvements; and

**WHEREAS**, Town staff has received quotes from State/Cooperative vendors (Exhibit A) for purchase of Concrete Picnic Tables, two quotes received utilized Cooperative purchasing contracts and two did not, and

**WHEREAS**, On October 17<sup>th</sup>, 2019 Town Council Approved Resolution No. 19-1526 adopting Town of Pinetop-Lakeside Purchasing and Cash Handling Policies and Procedures, and

**WHEREAS**, Section IV, sub-section B.1 states “Department heads are encouraged to also seek for alternate sources that may have better prices than the State/Cooperative purchasing contract”, and

**WHEREAS**, the quote received from Petersen Manufacturing was the lowest price quote received for concrete picnic tables, and

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona approve the purchase of Concrete Picnic Tables from the Petersen Manufacturing Company, Inc., in an amount not to exceed \$49,996.00 and authorize the Town Manager to execute all documents necessary to complete this transaction.
