

TOWN OF PINETOP-LAKESIDE

ORDINANCE 22-453

AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ADOPTING THE TOWN CODE AMENDMENTS TO CHAPTER 5.04.01 BUSINESS LICENSES GENERALLY, CHAPTER 16.16.020 PLATTING PROCEDURES AND REQUIREMENTS, STAGE 1 – PRE-APPLICATION MEETING, AND CHAPTER 16.24.140 DESIGN STANDARDS, WATER SYSTEMS CHANGING THE DEFINITION OF FIRE DISTRICT TO “THE DISTRICT HAVING AUTHORITY FOR FIRE PROTECTION AND ELIMINATING REFERENCE TO THE PINETOP FIRE DISTRICT AND THE LAKESIDE FIRE DISTRICT AND REPLACE BOTH WITH FIRE DISTRICT.

WHEREAS, the Town Council of the Town of Pinetop-Lakeside believes that amending the Town Code Chapter 5.04.01 BUSINESS LICENSES GENERALLY, CHAPTER 16.16.020 PLATTING PROCEDURES AND REQUIREMENTS, AND CHAPTER 16.24.140 DESIGN STANDARDS is in the best interest of the citizens of the Town.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, NAVAJO COUNTY, ARIZONA, as follows:

Section 1. **Adoption.** Chapter 5.04.01 BUSINESS LICENSES GENERALLY, CHAPTER 16.16.020 PLATTING PROCEDURES AND REQUIREMENTS, AND CHAPTER 16.24.140 DESIGN STANDARDS is hereby amended and adopted and made a part of that certain document known as the “Pinetop-Lakeside Town Code.” Three (3) copies of 5.04.01 BUSINESS LICENSES GENERALLY, CHAPTER 16.16.020 PLATTING PROCEDURES AND REQUIREMENTS, AND CHAPTER 16.24.140 DESIGN STANDARDS are on file with the Town Clerk of the Town of Pinetop-Lakeside, Arizona, which document was made a Public Record by Resolution No. 22-1640 of the Town of Pinetop-Lakeside, Arizona; and hereby referred to, adopted and made a part hereof as if fully set forth in this Ordinance.

Section 2. **Effective Date.** This Ordinance is effective when publication and posting pursuant to A.R.S. § 9-812 is accomplished.

Section 3. **Severability.** All ordinances, or parts of ordinances, adopted by the Town of Pinetop-Lakeside in conflict with the provisions of this ordinance or any part of the Town Code adopted herein by reference are hereby repealed, effective as of the day this ordinance is effective.

PASSED AND ADOPTED by the Mayor and Town Council in an open meeting by the Town Council, Town of Pinetop-Lakeside, Arizona, this 1st day of December 2022, to be effective upon the expiration of a thirty (30) day period following adoption and publication pursuant to A.R.S. § 9-812 is complete.
