RESOLUTION NO. 23-1661

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE OPIOID SETTLEMENT FUNDS AGREEMENTS WITH TEVA, ALLERGAN, CVS, WALGREENS AND WALMART AND AN INTERGOVERNMENTAL AGREEMENT WITH NAVAJO COUNTY REGARDING OPIOID SETTLEMENT FUNDS DISTRIBUTION

WHEREAS, the Town of Pinetop-Lakeside (“**Town**”) has entered into an agreement with the State of Arizona entitled the *One Arizona Distribution of Opioid Settlement Funds Agreement* (“**One Arizona Plan**”) that resulted from negotiations with defendants involved in the opioid crisis (the “**Opioid Defendants**”) due to the manufacturing, marketing, promoting, distributing, and dispensing opioids and the expansion of the opioid crisis;

WHEREAS, pursuant to the One Arizona Plan the Town entered into a first round of settlement agreements with Opioid Defendants in November 2021;

WHEREAS, the Arizona Attorney General has now asked the Town to participate in a second round of settlement agreements with: Teva, Allergan, CVS, Walgreens and Walmart (“**2023 Opioid Defendants**”);

WHEREAS, Navajo County (“**County**”) has asked the Town to enter into a document entitled “Intergovernmental Agreement for the Use of Opioid Settlement Proceeds Pursuant to the One Arizona Plan” (“**Opioid Settlement Distribution IGA**”) (Exhibit A); and

WHEREAS, to increase the amount of opioid settlement proceeds available to residents of the County and to coordinate the use of opioid settlement proceeds in the County, the Mayor and Town Council desire to approve the settlement agreements with the 2023 Opioid Defendants (the “**Opioid Settlement Agreements**”) (Exhibit B) and approve the Opioid Settlement Distribution IGA with the County.

NOW, THEREFORE, BE IT RESOLVED, that the Town Council of the Town of Pinetop-Lakeside, Arizona hereby:

1. Approves and authorizes the Mayor to sign the Opioid Settlement Agreements and the Opioid Settlement Distribution IGA; and
2. Authorizes the Mayor and Town Manager to take such administrative actions necessary to implement the Opioid Settlement Agreements and the Opioid Settlement Distribution IGA.
