RESOLUTION NO. 23-1687

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, NAVAJO COUNTY, ARIZONA, APPROVING TO ENTER INTO A GENERAL EASEMENT AGREEMENT BETWEEN THE THOMAS W. ISOM LIVING TRUST AND THE TOWN OF PINETOP-LAKESIDE FOR CONSTRUCTION AND MAINTENANCE OF A TOWN STORM WATER DRAINAGE SYSTEM.

WHEREAS, the storm water system for the Top of the Woods Unit One drainage area is currently not suitable to accommodate a one-hundred-year storm event.

WHEREAS, the Town of Pinetop-Lakeside wishes to improve the storm water drainage system for the Top of the Woods drainage area to accommodate a potential one-hundred-year storm event; and

WHEREAS, portions of the proposed storm water drainage system will be constructed on private property; and

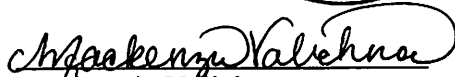
WHEREAS, the Town of Pinetop-Lakeside will enter into a General Easement Agreement with the Thomas W. Isom Living Trust to construct and maintain the storm water drainage system over their real property.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Pinetop-Lakeside, Navajo County, Arizona, hereby approve to enter into a general easement agreement between the Thomas W. Isom Living Trust and the Town of Pinetop-Lakeside; and authorize the Town Manager to execute all documents necessary in connection with this agreement.

The grantee agrees to maintain such public improvements which may be placed within said easement for the stated purpose.

Thence South 29°04'28" East, 41.13 feet;

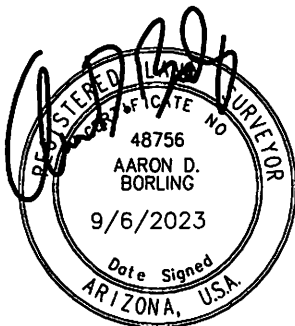
Thence South 00°01'17" West, 2.96 feet to a point on the south line of said parcel;

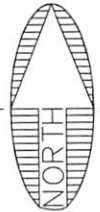
