**RESOLUTION NO. 24-1758**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, NAVAJO COUNTY, ARIZONA, RESCINDING RESOLUTION NO. 24-1730 WHICH DECLARED AND ADOPTED THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 30, 2024; AND ADOPT AND DECLARE THE REVISED RESULTS OF THE 2024 PRIMARY ELECTION.**

**WHEREAS**, the Town of Pinetop-Lakeside, Navajo County, Arizona, did hold a Primary Election on the 30<sup>th</sup> day of July 2024 for the election of three (3) Council Members with a term ending in 2028, and one (1) Council Member with a term ending in 2026; and

**WHEREAS**, the election returns were presented to and canvassed by the Town Council, thereby declaring and adopting the results of the Primary Election during an open meeting of the Town Council on August 15, 2024, attached hereto as Resolution No. 24-1730 (Exhibit A); and

**WHEREAS**, all four (4) candidates that ran for a Council seat with a term ending in 2028, received a majority vote; and

**WHEREAS**, Harry Turner, Todd Fernau, and Jennifer Brimhall were the three (3) candidates with the highest total of votes cast for the 4-yr. term; and

**WHEREAS**, on October 28, 2024, Council Member Elect Jennifer Brimhall respectfully withdrew her candidacy for Council Member Elect for the Town of Pinetop-Lakeside; and

**WHEREAS**, Jerry Smith was the fourth candidate that ran for a Town Council 4-yr. term; and

**WHEREAS**, Candidate Jerry Smith did receive a majority vote during the 2024 Primary Election which qualifies him to serve on Town Council; and

**WHEREAS**, the decision made by Jennifer Brimhall to withdraw her candidacy for Town Council, hereby qualifies candidate Jerry Smith to be declared elected to the Town of Pinetop-Lakeside Town Council with a term ending in 2028; and

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Town Council of the Town of Pinetop-Lakeside a, Navajo County, Arizona, as follows:

**Section 1:** Resolution No. 24-1730 is hereby rescinded.

**Section 2:** That the total number of ballots cast at said Primary Election, as shown by the Navajo County Election Official Report, was 1,174.

**Section 3:** That the number of ballots rejected was 18.

**Section 4:** That the votes cast for candidates of Council Member (4-yr. term) were as follows:






