RESOLUTION NO. 17-1407

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, DESIGNATING A PARK LOCATED AT THE CORNER OF JOHNSON ROAD AND HIGHWAY 260 IN PINETOP-LAKESIDE AS “*JACK BARKER MEMORIAL PARK*” IN HONOR OF FORMER TOWN ATTORNEY JACK BARKER.

WHEREAS, the Town of Pinetop-Lakeside recognizes citizens that it deems to be extremely valuable and who exemplify the mission and values of our Town in their service; and

WHEREAS, the Town wishes to recognize the significant contributions of the late Jack Barker for his years of service as the Town Attorney for over 20 years; and

WHEREAS, his love for Pinetop-Lakeside and all its residents earned him the respect and admiration of the community; and

WHEREAS, during the time Jack Barker lived in the Town of Pinetop-Lakeside he contributed greatly to the following:

- Mr. Barker gave selflessly of his time and energy for the benefit of many community organizations.
- Mr. Barker’s strong feelings for serving others and giving back to our community was evident with the countless hours he served on the Blue Ridge Unified School District Board, as White Mountain Apache Tribal Court of Appeals Judge, Sunrise Ski Area Junior Race Team Sponsor, Board Member of the Blue Ridge Scholarship Fund, and with the Rocky Mountain Elk Foundation.
- Mr. Barker as an Attorney, with vast experience and knowledge of the law served as the Navajo County Justice Court Judge Pro Tem, Navajo County Superior Court Commissioner and with the Arizona Supreme Court Education Services Faculty.




