

**TOWN OF PINETOP-LAKESIDE**

**RESOLUTION NO. 17-1414**

**A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, ACCEPTING THE PRIMARY BID IN THE AMOUNT OF \$76,180.00 AND ENTERING INTO A CONSTRUCTION CONTRACT WITH DEVELOPMENT SPECIALISTS, LLC TO COMPLETE THE WOODLAND LAKE PARK ACCESS ROAD MAINTENANCE PROJECT PHASE II, PROJECT NO. PW 17-003; AND AUTHORIZE THE TOWN MANAGER TO EXECUTE ANY AND ALL DOCUMENTS IN CONNECTION WITH THE PROJECT.**

**WHEREAS**, the Project is primarily federally-funded by USDA Secure Rural Schools & Communities Self-Determination Act of 2000; and

**WHEREAS**, the Town of Pinetop-Lakeside conducted a bid opening on May 24, 2017 for the Woodland Lake Park Access Road Maintenance Phase II Project No. PW 17-003 (“Project”); and

**WHEREAS**, the Town of Pinetop-Lakeside received two (2) sealed bids, with Development Specialists, LLC submitting the lowest, responsible primary bid in the amount of \$76,180.00; and

**WHEREAS**, Town Staff after reviewing both bid packets, and the qualifications of Development Specialists, LLC, recommends entering into to a construction Contract with the lowest responsible bidder, Development Specialist, LLC for this Project; and


**WHEREAS**, the Town of Pinetop-Lakeside is in agreement with the terms and conditions set forth in the Contract Documents between Development Specialists, LLC and the Town

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona approve Resolution No. 17-1414:

1. Accepting the primary bid in the amount of \$76,180.00 and entering into a construction Contract with Development Specialists, LLC to complete the Woodland Lake Park Access Road Maintenance Project Phase II Project No. PW 17-003; and
2. Authorizing the Town Manager to execute any and all documents necessary to complete this project.


