**RESOLUTION NO. 17-1435**

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE SPECIAL ELECTION HELD ON NOVEMBER 7, 2017.**

WHEREAS, the Town of Pinetop-Lakeside, Navajo County, Arizona did hold a Special Election on the 7<sup>th</sup> day of November, 2017 which was administered by the Navajo County Elections Department for the purpose of Franchise Agreements Proposition No. 413 – Arizona Water Company Franchise and Proposition No. 414 – Navopache Electric Cooperative, Inc. Franchise; and

WHEREAS, the election returns have been presented to and have been canvassed by the Navajo County Board of Supervisors on Tuesday, November 14, 2017, and as shown in the attached Exhibit A, and are hereby presented to the Pinetop-Lakeside Town Council; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Town of Pinetop-Lakeside, Arizona, as follows:

Section 1. That the total number of ballots cast at said Special Election, as shown by the Navajo County Election Official Report, was 800.

Section 2. That the number of ballots rejected was 1.

Section 3. That the votes cast for Proposition No. 413 – Official Title: Pursuant to Arizona Revised Statutes, the Town of Pinetop-Lakeside, Arizona seeks voter approval of a twenty-five year franchise to be granted to Arizona Water Company to use the Town’s public rights-of-way for the purpose of operating its water system and supplying water service within the Town, were as follows:

<b>Proposition No. 413</b>	<b>Total Vote</b>	<b>Percent of Votes</b>
A “ <b>YES</b> ” vote shall have the effect of granting a twenty-five year franchise to Arizona Water Company to use the Town’s public rights-of-way to operate its water system and supply water service within the Town.	<b>523</b>	<b>71.06%</b>
A “ <b>NO</b> ” vote shall have the effect of not granting a twenty-five year franchise to Arizona Water Company to use the Town’s public rights-of-way to operate its water system and supply water service within the Town.	<b>213</b>	<b>28.94%</b>

Section 4. That the votes cast for Proposition No. 414 – Official Title: Pursuant to Arizona Revised Statutes, the Town of Pinetop-Lakeside, Arizona seeks voter approval of a twenty-five year franchise to be granted to Navopache Electric Cooperative, Inc. to use the Town’s public rights-of-way for the purpose of operating its electric system and supplying electric energy within the Town, were as follows:

<b>Proposition No. 414</b>	<b>Total Vote</b>	<b>Percent of Votes</b>
A “ <b>YES</b> ” vote shall have the effect of granting a twenty-five year franchise to Navopache Electric Cooperative, Inc. to use the Town’s public rights-of-way to operate its electric system and supply electric energy within the Town.	<b>521</b>	<b>70.41%</b>
A “ <b>NO</b> ” vote shall have the effect of not granting a twenty-five year franchise to Navopache Electric Cooperative, Inc. to use the Town’s public rights-of-way to operate its electric system and supply electric energy within the Town.	<b>219</b>	<b>29.59%</b>


Section 5. That it is hereby found, determined, and declared of record, that Proposition No. 413 – Arizona Water Company Franchise was approved by the electors of the Town voting at said Special Election.

Section 6. That it is hereby found, determined, and declared of record, that Proposition No. 414 – Navopache Electric Cooperative, Inc. Franchise was approved by the electors of the Town voting at said Special Election.


Section 7. That this Resolution shall be in full force and effect immediately upon its adoption.
