

TOWN OF PINETOP-LAKESIDE

RESOLUTION NO. 17-1397

A RESOLUTION OF THE MAYOR AND TOWN COUNCIL OF THE TOWN OF PINETOP-LAKESIDE, ARIZONA, AUTHORIZING AN INTERGOVERNMENTAL AGREEMENT (IGA) BETWEEN THE TOWN OF PINETOP-LAKESIDE, CITY OF SHOW LOW AND NAVAJO COUNTY TO COMPLETE A SURFACE MAINTENANCE PROJECT.

WHEREAS, the participants to this Intergovernmental Agreement desire to engage in regional coordination and cost-sharing to provide surface maintenance (slurry seal) on Penrod/Porter Mountain Road; and

WHEREAS, the City of Show Low, Town of Pinetop-Lakeside and Navajo County are authorized by A.R.S. § 11-952 to enter into agreements for joint or cooperative action and therefore authorized to enter into this IGA; and

WHEREAS, a portion of Porter Mountain Road, and all of Penrod Road require surface maintenance; and


WHEREAS, the three jurisdictions agree that the surface maintenance on the roadway is more efficient and cost effective if it is performed by single contractor at the same time; and

WHEREAS, the Intergovernmental Agreement is attached as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Town Council of the Town of Pinetop-Lakeside, Arizona, hereby approve entering into an Intergovernmental Agreement between the Town of Pinetop-Lakeside, City of Show Low and Navajo County, and authorize the Town Manager to execute all documents necessary to complete the surface maintenance project.



EXHIBIT "A"

Intergovernmental Agreement
Between the
City of Show Low, the Town of Pinetop-Lakeside
and Navajo County

This Intergovernmental Agreement ("IGA") is entered into as of this 7th day of March, 2017 (the "effective date") by and between the City of Show Low ("City"), Town of Pinetop-Lakeside ("Town"), and Navajo County, Arizona ("County").

WHEREAS, the City, Town, and County are authorized by Arizona Revised Statute § 11-952 to enter into agreements for joint or cooperative action and therefore authorized to enter into this IGA; and

WHEREAS, portions of Penrod Road are located within the corporate limits of Show Low, Pinetop-Lakeside (Porter Mountain Road), and unincorporated Navajo County; and

WHEREAS, the roadway is due for surface maintenance; and

WHEREAS, the three jurisdictions agree that the surface maintenance on the road is more efficient and cost effective if it is performed by a single contractor at the same time; and

WHEREAS, the approximate total quantity of slurry is 115,300 square yards; and

WHEREAS, the approximate pro-rata distributions for the roadway are; City of Show Low – 55.9%, Town of Pinetop-Lakeside – 30.9%, Navajo County – 13.2%.

NOW, THEREFORE, the parties agree that the City of Show Low will prepare bid documents to solicit a single bid for the Penrod and Porter Mountain Roads work as part of Show Low's annual slurry seal bid, and each jurisdiction will pay its pro-rata share to the City of Show Low on a unit cost per square yard basis upon completion of the project.

IN WITNESS WHEREOF, the duly authorized representatives of the parties have executed this IGA as of the effective date.




